In addition, there are appropriated such sums as may be necessary under current law for salaries of the chief justice and associate justices of the court.

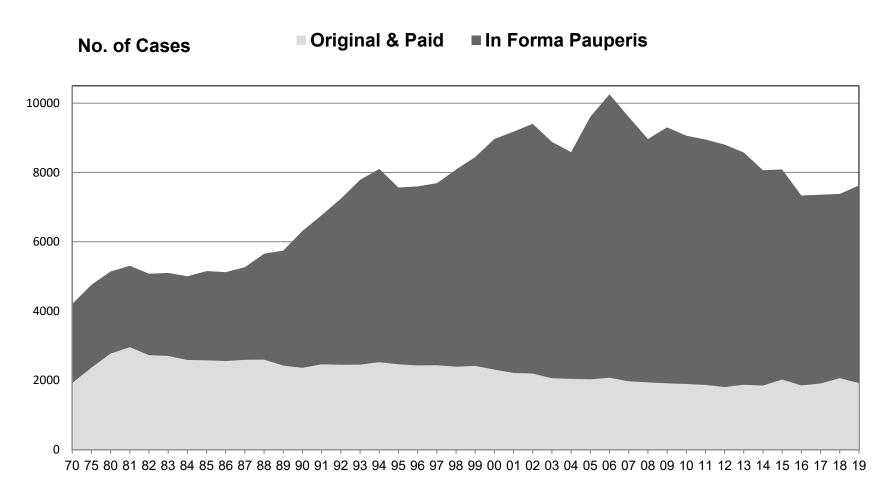

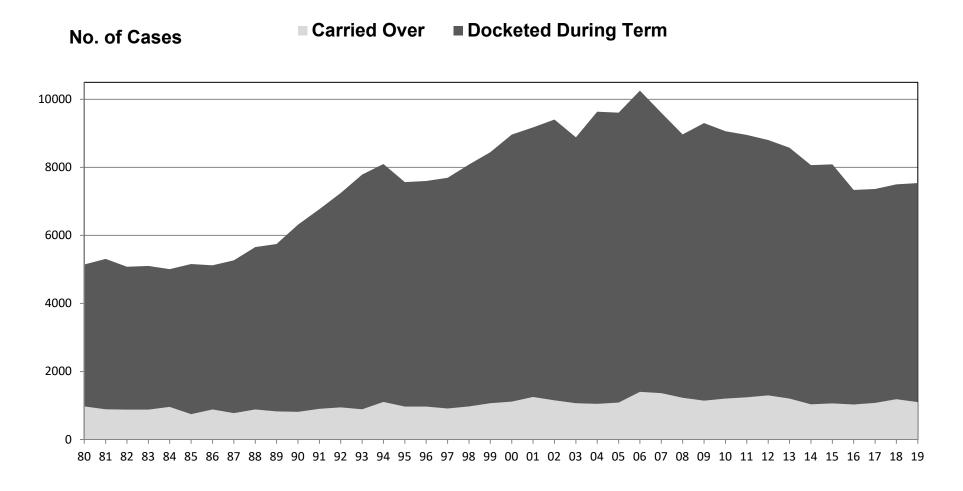

Cases on Docket By Type



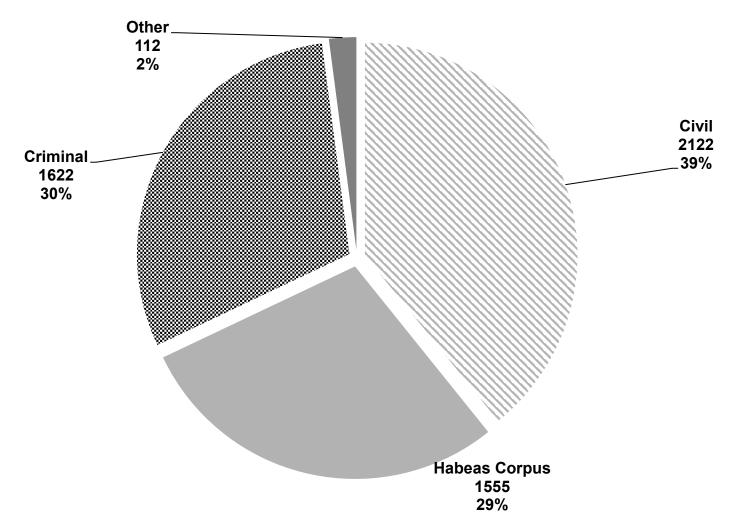

Cases Carried Over & Docketed



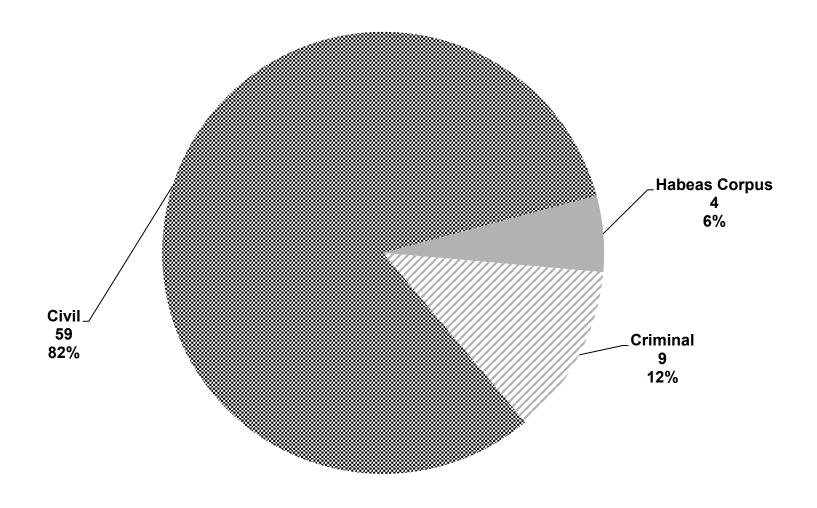

Cases Docketed By Type



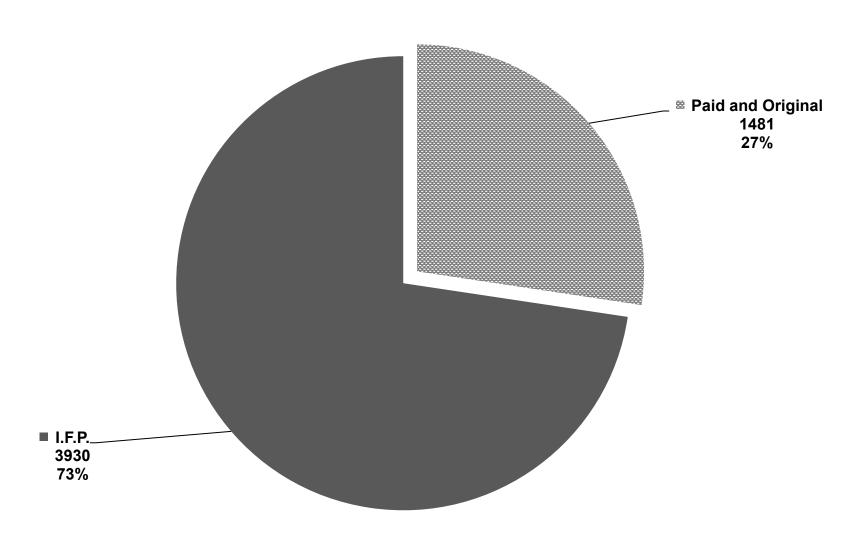

GENERAL STATEMENT AND INFORMATION

The Supreme Court Salaries and Expenses account funds salaries of the Chief Justice, eight Associate Justices, the Counselor to the Chief Justice, the four Statutory Officers of the Court, and the employees of the Court. The account also funds the necessary expenses of the Court, including printing and binding of the Supreme Court reports, purchasing books for the Supreme Court, and miscellaneous expenses.

The fiscal year (FY) 2022 request for the Court totals \$100,265,000. The request is the sum of \$2,763,000 of mandatory appropriations and \$97,501,000 of discretionary appropriations, including \$1,500,000 of no-year funding for planning and implementing periodic Court-wide technology and automation upgrades.

FISCAL YEAR 2021 APPROPRIATIONS

The judiciary built the FY 2022 discretionary budget request for the Supreme Court Salaries and Expenses account on the FY 2021 enacted appropriation, which is \$94,690,000. This amount fully funds the Supreme Court's FY 2022 requirements. For bill language, the judiciary used the language from P.L. 116-260, Financial Services and General Government Appropriations Act, 2021.

JUSTIFICATION OF CHANGES

The FY 2022 request for the Court includes \$2,763,000 for mandatory expenses and \$97,501,000 for discretionary expenses. The discretionary request is a 3.0 percent increase over the FY 2021 enacted level. The request includes \$2.8 million in necessary adjustments to maintain current services. The request also includes no-year funding for planning and implementing periodic Court-wide technology and automation upgrades totaling \$1,500,000.

Adjustments to base to maintain current services include funds for pay and benefits increases for current Justices and staff. Also included are increased costs of ongoing activities such as physical security and cybersecurity, supplies, equipment, furnishings, automation, and offsite warehouse space for activities that include mail screening.

ADJUSTMENTS TO BASE TO MAINTAIN CURRENT SERVICES

A. JUSTICES

1. Proposed 2022 pay adjustment

Mandatory Increase: \$21,000

The judiciary is assuming federal pay rates will increase by 1.0 percent in January 2022. The requested increase provides for the cost of nine months of the anticipated pay adjustment in FY 2022, from January 2022 to September 2022. (If the pay

adjustment included in the President's FY 2022 budget request is different from this 1.0 percent guidance, the judiciary will revise this line item in its FY 2022 budget re-estimate.)

2. Annualization of 2021 pay adjustment

Mandatory Increase: \$7,000

The requested increase provides for the annualized costs of a 2021 Employment Cost Index pay adjustment. Based on the enacted appropriation, federal pay rates for justices increased by 1.0 percent, effective as of January 2021. The requested increase provides for the cost of three months (from October 2021 to December 2021) of the 2021 pay increase in FY 2022.

3. Benefits increase

a. Health benefits

Mandatory Increase: \$3,000

Based on information from the Office of Personnel Management, agency health benefit premium contributions are projected to increase by an average of 3.0 percent both in January 2021 and January 2022. The requested increase annualizes the 2021 premium increase and includes a ninemonth provision for an estimated 3.0 percent increase anticipated for FY 2022.

b. FICA adjustment

Mandatory Increase: \$4,000

Based on information from the Social Security Administration, employer contributions to the Old Age, Survivor, and Disability Insurance (OASDI) portion of the FICA tax will increase in 2021. The salary cap for OASDI increased from \$137,700 to \$142,800 in January 2021. The requested amount is needed to pay the agency's contribution in FY 2022.

B. PERSONNEL

Pay and Benefit Adjustments

4. Proposed 2022 pay adjustment

Requested Increase: \$478,000

The judiciary is assuming federal pay rates will increase by 1.0 percent in January 2022. The requested increase provides for the cost of nine months of the anticipated pay raise in FY 2022, from January 2022 to September 2022. (If the pay adjustment included in the President's FY 2022 budget request is different from this 1.0 percent guidance, the judiciary will revise this line item in its FY 2022 budget re-estimate.)

5. Annualization of 2021 pay adjustment

Requested Increase: \$173,000

The requested increase provides for the annualized costs of a 2021 Employment Cost Index pay adjustment for federal

civilian workers. Based on the enacted appropriation, federal pay rates increased by an average of 1.0 percent, effective as of January 2021. The requested increase provides for the cost of three months (from October 2021 to December 2021) of the 2021 pay increase in FY 2022.

6. Promotions and within-grade increases

Requested Increase: \$478,000

The requested increase provides for promotions and withingrade increases for personnel. The salary plan for judicial support personnel provides for periodic within-grade increases for staff who receive at least a satisfactory performance rating.

7. Benefits increases

a. Health benefits

Requested Increase: \$119,000

Based on information from the Office of Personnel Management, agency health benefit premium contributions are projected to increase by an average of 3.0 percent both in January 2021 and January 2022. The requested increase annualizes the 2021 premium increase and includes a ninemonth provision for an estimated 3.0 percent increase anticipated for FY 2022.

b. FICA adjustment

Requested Increase: \$23,000

Based on information from the Social Security Administration, employer contributions to the Old Age, Survivor, and Disability Insurance (OASDI) portion of the FICA tax will increase in 2021. The salary cap for OASDI increased from \$137,700 to \$142,800 in January 2021. The requested amount is needed to pay the agency contribution in FY 2022.

c. FERS adjustment

Requested Increase: \$626,000

Consistent with guidance from the Office of Management and Budget, funds are requested for an increase in the agency contribution rate to Federal Employees Retirement System (FERS) plans for FY 2022. For most employees, the agency contribution rate will increase from 17.3 percent to 18.4 percent. Any FERS increase is in accordance with revised estimates of the cost of providing benefits by the Board of Actuaries of the Civil Service Retirement and Disability System.

C. OTHER ADJUSTMENTS

General Inflationary Adjustments

8. Inflationary increases in charges for contracts, services, supplies, and equipment

Requested Increase: \$521,000

Consistent with guidance from the Office of Management and Budget, the requested increase is required to fund inflationary adjustments of 2.0 percent for operating expenses such as travel, communications, printing, contractual services, supplies and materials, and furniture and equipment.

9. Inflationary increase and adjustments in GSA space rental costs

Requested Increase: \$11,000

This request represents a 4.0 percent increase in the cost of GSA space rental charges for warehouse space in FY 2022.

10. Annualization of four new positions provided for in FY 2021

Requested Increase: \$383,000 FTE: 2

The FY 2021 enacted appropriation provided funding necessary for four new administrative positions, hardware and software system upgrades, specialized services, and other costs associated with administrative improvements to enhance the Supreme Court's security programs. This request includes funding for the remainder of those positions' salaries and benefits, which were pro-rated for half of the fiscal year.
