

**Report of the Director of the Administrative Office
of the United States Courts
on Applications for Delayed-Notice Search Warrants and Extensions**

The USA Patriot Improvement and Reauthorization Act of 2005 requires the Director of the Administrative Office of the United States Courts (AO) to transmit to Congress annually a full and complete report summarizing information reported by judges to the AO on delayed-notice search warrants. The report is to include the number of applications for warrants and extensions of warrants authorizing delayed notice and the number of such warrants and extensions granted or denied during the preceding fiscal year. The requirement to report this information to Congress began with the fiscal year ending September 30, 2007.

This report covers applications for delayed-notice search warrants and extensions between October 1, 2015, and September 30, 2016.

Reporting Requirements of the Statute

Any federal or state judge who issues or denies a federal warrant authorizing delayed notice, or an extension of such a warrant, is required to file a report on the warrant with the AO (18 U.S.C. § 3103a(d)(1)). This report is to be furnished not later than 30 days after the expiration of the warrant's notice period (including any extensions to the notice period) or 30 days after the denial of the warrant or the request for extension. The report must include the offense specified in the warrant or application, the period of delay authorized, the number and duration of any extensions, and the action taken on the application.

The AO is required to report annually to Congress on the information submitted by judges for the preceding fiscal year. This report must include the number of applications for delayed-notice search warrants and extensions and the number of warrants and extensions granted or denied (18 U.S.C. § 3103a(d)(2)).

Summary and Analysis of Reports for Fiscal Year 2016

Summary data on applications for delayed-notice search warrants and extensions for fiscal year 2016 are shown in Table 1. A total of 9,191 warrant requests and a total of 6,050 requests for extensions were reported for the fiscal year ending September 30, 2016. Thirty-five of the applications reported were denied, 42 of the applications were granted as modified, and 15,164 were granted as requested.

Judges in 92 federal judicial districts reported actions on applications for delayed-notice search warrants or extensions. The highest numbers of applications were reported by judges in the Northern District of Illinois (1,186), the District of Oregon (851), the Eastern District of Michigan (845), the Western District of Texas (783), the Northern District of Ohio (674); and the District of Maryland (635); applications in these six districts accounted for a third of all applications reported. Of the 15,241 applications reported by all districts, 13,824 (91 percent) were reported by federal magistrate judges, and 1,412 were reported by federal district judges.

Five applications were reported by state judges.

The periods of delay specified ranged from 1 day to 999 days. The most frequently reported period of delay was 30 days, specified in 6,913 (45 percent) of the applications that were granted (see Graph 1). Requests for extensions to a delay numbered from 1 to 91, with first extensions being the most frequently requested in 2016 (see Graph 2).

Offenses

Table 2 presents the types of offenses specified in delayed-notice search warrant and extension requests reported in 2016. Drug offenses were specified in 82 percent of applications reported, followed by fraud (4 percent), extortion/racketeering (3 percent), sex offenses (2 percent), weapons (2 percent), and fugitive/escape (2 percent).

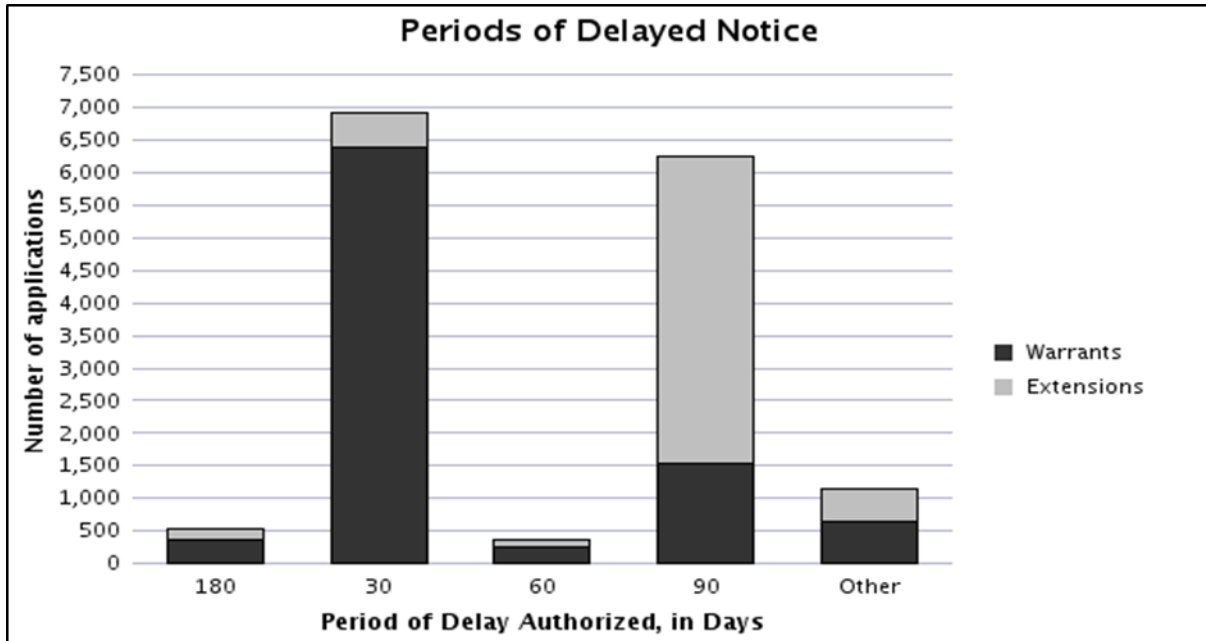
