## Dear Honorable Judges,

Since my testimony on October 30, 2018 at the Thurgood Federal Judiciary Bldg. my quest to institute screening for Axis I to Axis V Mental Illness in all candidates (and existing judges for which there are complaints filed now and in the future) for vacancies in the Federal Courts--------has taken a turn I didn't expect. I have become the focus of death threats. As of today November 13, 2018 the DOJ and the FBI have joined the US Marshall's Office in investigation. I have alleged that the courts, police, deputies, jailers, and all operating under Color of Law are not enforcing 18USC249, 245 and 241, the Matthew Shepard Hate Crime Act of 2009 passed by the US House and Senate and signed by the President. I pray that you, the committee, will pass new rules to include terms of impeachment of Justices of the US Supreme Court. I have filed for impeachment for Brett Kayanaugh and understand that all such complaints are now sent to the 10th Circuit under the Chief Judge Timothy M. Tymkovich due to recusal by Chief Judge Merrick Garland, DC Court of Appeals for the District of Columbia. Since Chief Justice Tymkovich denied appeal at the 10th Circuit of my "Conversion Therapy" case from Aspen, Co. I will ask that Judge Tymkovich recuse himself in all matters that concern my lesbian lifestyle in the form of complaints alleging homophobia, sadomasochism, bias, prejudice and other forms of irrational behavior that touch on gender discrimination. I would like to see the committee mandate that there be gender equality in the appointments of all future judgeships to reflect the gender ratio of the population of American citizens which would be at least 50-50%.
