Re: Amendment Needed on Question #4 on Voluntary Petition for Individuals Filing for Bankruptcy – Official Form 101

Dear :

Current Question #4 on the Voluntary Petition for Individuals Filing for Bankruptcy (Official Form 101) which asks debtors to disclose "Your Employer Identification Number (EIN), if any" is quite understandably causing significant confusion for a growing number of pro se debtors. Here's how the question currently appears on Official Form 101:

In response to this question, some *pro se* debtors are reasonably providing the EIN of *their* employer rather than an EIN issued to them *as an employer*). For example, a debtor who works for Amazon listed Amazon's EIN in response to this question. Because multiple debtors are making the same mistake across the county, that causes cm/ecf's repeat filer monitoring system to pick up that same EIN and erroneously report that the debtor has prior filings and, thus, may not be eligible for a discharge. Here's a real example of such an erroneous report in a Chapter 7 case filed in our court (case no. 24-13235):

As this example illustrates, other debtors made the same mistake of erroneously listing Amazon's EIN as *their* EIN on their petitions in multiple courts across the county, and this problem will only grow over time until Question #4 on the Voluntary Petition is amended. For further background, it is my understanding that Question #4 was changed to its present vague language several years ago. Previously, at least in 2017, Question #4 used to read much more clearly as follows:

In summary, Question #4 in its present form is so vague that it is understandably creating confusion and wasting the time and resources of the public and our offices. I strongly urge that Question #4 be immediately revised to something similar to how it previously existed in 2017 or at least to indicate that what is requested is: "Any EIN issued to you as an employer."
